AT Angela Giron moved to Accept the resignation of Stephen Varela effective immediately, seconded by Matt Garcia with a unanimous vote, no discussion. Motion carried.

Oath of Office for Ex-Officio Members

Angela read the Oath of Office for the Faculty Reps (CCA: Laycee Rexroth-remote, ECMS: Arjun Sahdev-remote; DHPH: Dr. Elizabeth Aragon Blanton), Higher Education Rep (Fred Galves), and Student Rep (Jesus Torres Valdovinos); the official swearing in process is complete for these individuals.

- I Angela read the Oath of Office for the new voting members (Don Ortega, Community Rep and Joseph Garcia, Parent Rep); the official swearing in process is complete for these individuals. Don was in attendance virtually and Joseph joined the Board in-person once sworn in.
- AT Matt Garcia moved to approve Angela Giron as the Interim Board President indefinitely until further review can take place, seconded by Joseph Garcia, with a unanimous roll call vote of all 4 members, no
- I Dr. Duran recommended that the Public Forum be moved up in the agenda to take place now rather than at the end of the meeting.
- AT Matt Garcia moved to approve Public Forum be moved up on the agenda to take place now, seconded by Joseph Garcia, with an unanimous vote, no discussion. Motion carried.

Public Forum

1. Dr. Aragon Blanton – Stated that she wrote her letter months ago and has been waiting to give her opinion. "The statements I am making now are mine and mine alone and I want them documented." She went on to say that there has been a certain political movement with a particular board member. He did not mention the 3 generations of the Hispanic movement Chicano that were present in the audience in August and who are fighting for equality. What is the purpose of him serving on our Board (referencing Stephen Varela). Hal Stevens created a hostile work environment and stated over and over that Mr. Varela was his only boss he had to listen to. This person (referencing Mr. Varela) stated he has a background in Chicano studies and did not act accordingly. Dr. Aragon Blanton stated" Did you know that strong females have participated in all movements and what message does Mr. Varela and Mr. Stevens recent behavior towards women send to our students when they see only females being fired and targeted. My agenda is to educate children and I need to make clear that I will not be treated in a rude or disrespected manner. I expect to be treated as a professional. As a staff we believe that Colorado did not want him, Pueblo did not want him, and we do not want him.



- 2. Maria Fernandez I do not need to go up there after Dr. Aragon's speech. She said it all perfectly.
- 3. Judge Dennis Maes I want to thank the CHPA community and staff for being brave and standing up. All they wanted was their school back and in the face of losing their jobs they still stood up for what was right. Congrats on taking your school back! Quite frankly the bylaws got in the way and we still have work to do to fix that. To Dr. Duran thank you for coming back after your short retirement and we thank you for stepping back in. Thank you to Mr. Orona for being willing to step in during the tough times. On ht4 topic of Governance if you are going to have bylaws then live by them. If they need adjusted, then adjust them. Mrs. Giron you are tasked with a difficult thing in takin this meeting over in a moment's notice. You will be helping Dr. Duran do the agenda from now on and a little session about Board Governance with the staff would be beneficial. Spend the resources necessary to get good programming and student achievement. Mr. Orona knows what he is talking about so trust in him and you are in good hands now. Let's face it, the financial conversations that have been happening are concerning and there is reason for this community to be concerned. We need an update and a report about the finances asap. D60 had a meeting and talked about the financial state of CHPA if there is an issue, own up to it and fix it. The reason this school was founded is back it is reborn and people are here for the right reason now and not for their personal agendas as the past persons who have now left.
- 4. Rusty McBee I will be brief. I had comments prepared that do not need to be stated now with the news of Varela's resignation that we got earlier. Thank you to Anthony Nunez, James Bortello, Judge Dennis Maes, Garrison Ortiz, Dr. Duran, and all those community members who stood by us through all of it! It is obvious that the right values are back at the forefront thank you all very much!
- 5. Theresa Martinez-Blasing I had statement prepared but now I do not need to read it like everyone else. Thank you to the existing Board Members and leading with professionalism and the right focus. Thank you to the community Juan Espinosa and Shannon Behling (Mr. McBee gave a shout out). I agree with Mr. McBee, we are moving forward in the right direction and it feels good!
- 6. Nick Angiocchi hours spent preparing a statement out the window but that is okay! The news we got today is great and it feels good and warm. Look forward to the growth and healing and happy to be a part of it! Thank you to Mrs. Giron for all her true passion and love for the school. CHPA is back in charge of CHPA. Si se puede!
- 7. Kim Sanchez Thank you to everyone and I was planning to speak tonight to ask for Varela to resign again but now we finally made it! As a building leader, it has been a challenge to manage this on top of the academic needs for our students. We can focus on the students and not the things that were making it more challenging.
- 8. Bernadette Lujan I am not sure I am at the right Board Meeting this seems to be all about the business end of matters. Maybe I should not speak because it is about personnel matters. Mrs. Giron asked Mr. Orona what should be done. Orona recommended that it go through administration first next step is Dr. Duran and this will be followed up. Bernadette said she is not going away. Giron said this will happen by the end of the week.

a. CEO's Report

Due to a confluence of events, a perfect storm resulted in the finance department this past summer which included: the loss of senior finance personnel; two weeks with only one staff member; no CFO hired and two new finance staff hired in late August. This resulted in the loss of time to prepare adequately the Trial Balance which was due September 30, 2022. Simultaneously due to the loss of staff and the steep learning curve of new staff we were behind in requesting funds due to CHPA, which resulted in a cash flow problem to cover payable bills. While we worked hard to recoup funds and made progress in paying vendors, we are still catching up and plan significant catching up in November and December. As a result of the perfect storm, we are still working on completing the Trial Balance now with the assistance of D60 personnel. With completing this task, we can provide the info to our auditors to complete the Annual Audit which is also late as well as the 1st Quarter Financial Report. We fully realize not meeting the deadlines is

not what was to happen. As such, D60 sanctioned CHPA as per our contract and withheld 5% of our PPR payment and will continue until we can meet deadlines which is appropriate. Systems are being put into place for this type of scenario can be addressed appropriately if it occurs in the future.

I happy to be here and Pueblo is my hometown. I am a lawyer and law professor out of California. There is a partnership being sought for online programming —

Pueblo is going to have a huge apprenticeship program put in place (PTECH). CU Law School has reached out to do a program to teach students "street law" so he will work in this with Dr. Duran.
