### 4. Enrollment & Marketing Report

Enrollment I

Executive Director, Fred Segura shared on behalf of Robin Archuleta current enrollment CCA 343, ECMS 262, DHPH 234, total current enrollment 839. Fred shared that this year's numbers do not follow previous historical trends. Mr. Segura shared reasons of low enrollment to include students relocating out of area, governance and leadership, programs and athletics, bullying and safety in the middle school, lack of communication with principal an CEO, rumors of school closing, lack of end of year ceremonies, phone systems, credit retrieval, and location (closer to home).

Mr. Segura reviewed the many ways in which CHPA has been marketed in-house such as, social media, flyers, open-houses, tours of new facilities, all calls. CHPA also incorporated outside marketing through KRDO and Digital Hart Media.

Linda Jones of KRDO thanked the BOD for letter her share her marketing strategies for CHPA. She shared her goal was to increase enrollment and highlighted 2 30 second commercials and 2 two-minute interviews. The KRDO campaign will run through September 29, 2024. Ms. Jones will open the campaign to reach people new to the area and the additional zip code of 81008. She would also like to produce a testimonial type commercial and include school choice and extra-curricular activities.

Nicki Hart presented an overview of digital marketing efforts that include Facebook, and digital banner adds that target specific audiences for effective marketing. Ms. Hart advised keeping social campaigns running year-round for the best results.
